Situated in the Village of Orange, County of Cuyahoga, State of Ohio and known as being the Detention Basin Parcel in the Lot Split and Dedication Plat of Chagrin Highlands Orange Place Lot 3 as shown by the recorded plat in Volume 307 of Maps, Pages 54-55 of Cuyahoga County Records and all of Blocks A and B and part of Block C in the Consolidation and Dedication Plat of a Portion of Orange Place as shown by the recorded plat in Volume 315 of Maps, Pages 44-45 of Cuyahoga County Records, all being part of Original Warrensville Township, Lot No. 70 and Orange Township, Lot No. 1, Tract No. 4 and is further bounded and described as follows:

Beginning at the intersection of the center line of Harvard Road (variable width) with the center line of Orange Place (variable width). Thence North 00°-21'-40" West, along said center line of Orange Place, a distance of 138.68 feet to a point of curvature therein and principal place of beginning of the land herein described;

- Course 1 Thence North 89°-38'-20" East, a distance of 67.00 feet to a point of curvature in an Easterly right of way line of said Orange Place;
- Course 2 Thence Northwesterly, along said Easterly right of way line of Orange Place, along the arc of a curve deflecting to the left, a distance of 108.68 feet to a curved turnout therein. Said arc having a radius of 245.00 feet, a central angle of 25°-24'-59" and a chord which bears North 13°-04'-09.5" West, a distance of 107.79 feet;
- Course 3 Thence Northeasterly, along the arc of said curved turnout deflecting to the right, a distance of 41.94 feet to the point of tangency in a Southeasterly right of way line of Pine Crest Drive (60 feet wide and variable). Said arc having a radius of 30.00 feet, a central angle of 80°-05'-59" and a chord which bears North 14°-16'-20.5" East, a distance of 38.61 feet;
- Course 4 Thence North 54°-19'-20" East, along said Southeasterly right of way line of Pine Crest Drive, a distance of 3.16 feet to a point of curvature therein;
- Course 5 Thence Northeasterly, continuing along said Southeasterly right of way line of Pine Crest Drive, along the arc of a curve deflecting to the left, a distance of 59.79 feet to an angle point therein. Said arc having a radius of 180.00 feet, a central angle of 19°-01'-55" and a chord which bears North 44°-48'-22.5" East, a distance of 59.52 feet;

Said arc having a radius of 155.00 feet, a central angle of 82°-10'-40" and a chord which bears South 41°-27'-00" East, a distance of 203.74 feet;
- Course 21 Thence North 89°-38'-20" East, a distance of 45.00 feet to the aforesaid center line of Orange Place;
- Course 22 Thence Northwesterly, along said center line of Orange Place, along the arc of a curve deflecting to the left, a distance of 123.28 feet to the center line of aforesaid Pine Crest Drive. Said arc having a radius of 200.00 feet, a central angle of 35°-19'-00" and a chord which bears North 18°-01'-10" West, a distance of 121.34 feet;
- Course 23 Thence North 54°-19'-20" East, along said center line of Pine Crest Drive, a distance of 92.01 feet to a point of curvature therein;
- Course 24 Thence North 35°-40'-40" West, a distance of 30.00 feet to the point of tangency in a Northwesterly right of way line of said Pine Crest Drive;
- Course 25 Thence South 54°-19'-20" West, along said Northwesterly right of way line of Pine Crest Drive, a distance of 8.85 feet to a curved turnout therein;
- Course 26 Thence Northwesterly, along the arc of said curved turnout deflecting to the right, a distance of 39.10 feet to the point of tangency in a Northeasterly right of way line of aforesaid Orange Place. Said arc having a radius of 30.00 feet, a central angle of 74°-40'-02" and a chord which bears North 88°-20'-39" West, a distance of 36.39 feet;
- Course 27 Thence Northwesterly, along said Northeasterly right of way line of Orange Place, along the arc of a curve deflecting to the left, a distance of 168.27 feet to the point of tangency therein. Said arc having a radius of 245.00 feet, a central angle of 39°-21'-02" and a chord which bears North 70°-41'-09" West, a distance of 164.98 feet;
- Course 28 Thence South 89°-38'-20" West, along a Northerly right of way line of said Orange Place, a distance of 203.80 feet to a point of curvature therein;
- Course 29 Thence Northwesterly, along a Northeasterly right of way line of said Orange Place, along the arc of a curve deflecting to the right, a distance of 317.89 feet to the point of tangency therein. Said arc having a radius of 320.00 feet, a central angle of 56°-55'-06" and a chord which bears North 61°-54'-07" West, a distance of 304.98 feet;

- Course 31 Thence Northwesterly, continuing along said Northeasterly right of way line of Orange Place, along the arc of a curve deflecting to the right, a distance of 49.67 feet to the Northwesterly corner of the aforesaid Detention Basin Parcel. Said arc having a radius of 470.00 feet, a central angle of 06°-03'-20" and a chord which bears North 30°-24'-54" West, a distance of 49.65 feet;
- Course 32 Thence North 89°-03'-16" East, along the Northerly line of said Detention Basin Parcel, distance of 249.29 feet to the Northeasterly corner thereof;
- Course 33 Thence South 00°-56'-44" East, along the Easterly line of said Detention Basin Parcel, distance of 202.60 feet to the Northwesterly corner of aforesaid Block B;
- Course 34 Thence North 89°-38'-20" East, along the Northerly line of said Block B, distance of 532.76 feet to the Northeasterly corner thereof and a Westerly right of way line of aforesaid Pine Crest Drive;
- Course 35 Thence Southwesterly, along said Westerly right of way line of Pine Crest Drive, along the arc of a curve deflecting to the right, a distance of 114.53 feet to said point of tangency therein. Said arc having a radius of 120.00 feet, a central angle of 51°-41'-00" and a chord which bears South 26°-58'-50" West, a distance of 110.23 feet;
- Course 36 Thence South 35°-40'-40" East, a distance of 30.00 feet to the aforesaid center line of Pine Crest Drive;
- Course 37 Thence South 54°-19'-20" West, along said center line of Pine Crest Drive, a distance of 92.01 feet to the aforesaid center line of Orange Place;
- Course 38 Thence Southeasterly, along said center line of Orange Place, along the arc of a curve deflecting to the right, a distance of 123.28 feet to the principal place of beginning. Said arc having a radius of 200.00 feet, a central angle of 35°-19'-00" and a chord which bears South 18°-01'-10" East, a distance of 121.34 feet. Said parcel containing 3.5604 Acres (155,093 Square Feet) of land.
