**ORDINANCE NO. 2017-34**

**AN ORDINANCE  
 AMENDING SECTION 147.15(B) OF THE CODIFIED  
 ORDINANCES OF ORANGE VILLAGE TO CONFORM TO  
 THE POLICE COLLECTIVE BARGAINING AGREEMENT  
 FOR THE CONTRACT PERIOD JANUARY 1, 2017  
 THROUGH DECEMBER 31, 2019.**

WHEREAS, Council desires to amend Section 147.15(b) to conform the provisions in the Code with the provisions in the Police Collective Bargaining Agreement for the Contract Period January 1, 2017 through December 31, 2019.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF ORANGE VILLAGE, CUYAHOGA COUNTY, STATE OF OHIO:**

SECTION 1. That Section 147.15, Longevity, of the Codified Ordinances is hereby amended to read and provide, in its entirety, as follows:

**“147.15 LONGEVITY.**

\*\*\*

(b) Full-time employees hired on or after January 1, 1998, shall be eligible in accordance with the following longevity schedule for their years of full-time continuous service with the Village:

<u>Years of Service</u>	<u>Annual Payment</u>		
	<u>2017</u>	<u>2018</u>	<u>2019</u>
5-10 <del>to</del> 9 years	\$1,250.00	\$1,450.00	\$1,450.00
10-15 <del>to</del> 14 years	\$1,300.00	\$1,500.00	\$1,500.00
15-20 <del>to</del> 19 years	\$1,400.00	\$1,600.00	\$1,600.00
20 <del>or more</del> years or more	\$1,750.00	\$1,950.00	\$1,950.00

SECTION 2. That existing Section 147.15(b) of the Codified Ordinances of Orange Village, and any ordinance or any part of any ordinance in conflict with this Ordinance, are repealed.

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Chapter 105 of the Codified Ordinances of Orange Village.

SECTION 4. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
