**ORDINANCE NO. 2018-17**

**AN ORDINANCE  
 AMENDING SECTION 145.08 OF THE CODIFIED ORDINANCES  
 OF ORANGE VILLAGE REGARDING THE FIRE  
 DEPARTMENT'S ADDITIONAL HOLIDAY COMPENSATION.**

WHEREAS, upon the recommendation of the Fire Chief, this Council desires to change the time(s) considered to be holidays by amending Section 145.08 of the Codified Ordinances of Orange Village.

**NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF ORANGE VILLAGE, CUYAHOGA COUNTY, STATE OF OHIO:**

SECTION 1. That Section 145.08, Additional Holiday Compensation, of the Codified Ordinances is hereby amended to read and provide, in its entirety, as follows:

**“145.08 ADDITIONAL HOLIDAY COMPENSATION.**

(a) Each member of the Fire Department who is scheduled to work a shift and works that shift at the Fire Department for the days and times designated in subsection (b) hereof shall receive “holiday compensation” at a rate one and one-half (1 ½) times the member’s regular holiday pay.

(b) For the purposes of “holiday compensation,” as described in subsection (a) hereof, the following times and days shall be considered “holidays”:

<u>Holiday</u>	<u>Hours</u>
New Years Day	all day
Memorial Day	all day
July 4 <sup>th</sup>	all day
Labor Day	all day
Thanksgiving Day	all day
Christmas Eve Day	after 3 7 p.m.
Christmas Day	all day
New Years Eve	after 3 7 p.m.


(c) “Holiday Compensation” shall not be paid to members of the Fire Department who respond to emergency calls on the days and times noted in subsection (b) hereof. Such additional compensation shall only be paid to members of the department who are scheduled to work a shift at the Fire Department, and who in fact work that shift.”

SECTION 2. That existing Section 145.08 of the Codified Ordinances of Orange Village and any ordinance or any part of any ordinance in conflict with this Ordinance are repealed to the extent of the conflict.

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Chapter 105 of the Codified Ordinances of Orange Village.

SECTION 4. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.


