ORDINANCE NO. 2018-8

**AN ORDINANCE
APPOINTING A CHARTER REVIEW COMMISSION PURSUANT TO
ARTICLE XI OF THE ORANGE VILLAGE CHARTER, AND
DECLARING AN EMERGENCY.**

WHEREAS, Article XI of the Orange Village Charter provides: “Within eight (8) years of January 1, 2002, and within every eight (8) years of the appointment of the most recent Charter Review Commission, Council shall, by ordinance, establish and appoint members to a Charter Review Commission. The Commission shall review the Charter and make such recommendations to Council as the Commission may deem to be appropriate;” and

WHEREAS, Council has previously enacted Ordinance No. 2018-4, which appointed a Charter Review Commission for 2018; and

WHEREAS, this Council desires to amend the membership of the 2018 Charter Review Commission.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF ORANGE VILLAGE, CUYAHOGA COUNTY, STATE OF OHIO:

SECTION 1. That this Council hereby appoints the following individuals to serve on the Charter Review Commission:

Brandon Duber, Chair
Lisa Perry, Co-Chair
Zach Glazer
Alan Charnas
Jim Becker

SECTION 2. That the Charter Review Commission shall begin its review of the Orange Village Charter in February of 2018, at a time mutually convenient to a majority of the Members of the Commission and shall submit a written report to Council summarizing its review and recommendations by July 1, 2018. The Charter Review Commission may adopt such rules to govern its procedure as it may deem expedient for conducting its business.

SECTION 3. That the actions of this Council concerning and relating to the passage of this Ordinance were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 105 of the Code of Ordinances of Orange Village.

SECTION 4. That Ordinance No. 2018-4 is repealed in its entirety.

SECTION 4. That this Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of Orange Village and, further, for the reason that the work of the Charter Review Commission must complete its work in time to place any proposed amendments to the Charter on the November 2018 ballot; wherefore, this ordinance shall be in full force and effect from and after its adoption and approval by the Mayor, provided it receives the affirmative vote of five (5) members of Council, otherwise it shall take effect and be in force from and after the earliest period allowed by law.


