Service Department Container Drop-Off Program

The Service department has a program that provides residents a dumpster/container service for the easy disposal of brush, yard waste, construction debris and household debris. Because the trucks that deliver these containers are used for snow removal, the containers are only available during the months of April through November (weather permitting).

The containers are rented out on a first-come-first serve basis and residents should call at least three days in advance to rent a container. Rentals are 5 days maximum.

The Village has four sizes, a six (6) yard container, eight (8) yard container, ten (10) yard container and twelve (12) yard container.

Do not overload the containers. Material should be loaded level and evenly and shall not extend higher than the sidewalls of the container. If the container is overloaded and no one is home to correct the situation, the Service Department will remove the excess material, leave it on-site and a fee will be assessed.

This service is for residents only. If you hire a contractor to perform work, they must dispose of the building material, yard waste, brush or trees.

ACCEPTABLE LOADS (DO NOT MIX; CHOOSE ONE OF THE FOLLOWING)

Household Items- appliances (all Freon must be removed), furniture, clothing, toys, cooking utensils, etc. General clean-out/move-outs of homes, basements, garages

Construction Debris- drywall, tile, linoleum, insulation, siding paneling, windows, decking, doors, roofing material, etc. No household items. General construction debris from do-it-yourself projects

Yard Waste- grass clippings, leaves, weeds, mulch, hedge trimmings, plantings, straw, earth, sticks and twigs and small branches

Small tree- logs under 12" in diameter

Large tree- logs over 12" in diameter

Railroad ties

Clean fill-Bricks, stone, concrete, asphalt, dirt, block

Stumps

Note: If residents mix different types of material in the container as listed above, you will be billed for any additional dumping costs of your container incurred by the Village.

RESTRICTED ITEMS: HOUSEHOLD HAZARDOUS WASTE (HHW)

Do not dispose of any household hazardous waste into any Village waste container. Household Hazardous waste such as medical waste, oil-based paint, motor oil, fuel, pesticides and insecticides, fertilizers, garden chemicals, mercury, Freon, car batteries, aerosols, propane cylinders, stains and varnishes, thinners, turpentine, cleaners/acid, bleaches, antifreeze etc. is not permitted.

Please dispose of these products by using the Village Household Hazardous Waste collection program. See the Village recycle calendar or Village website (www.orangevillage.com) for dates and regulations.

Note: If any hazardous material is located in the container, it will be the responsibility of the resident to remove the material and dispose of correctly. If any material is found in the container that is determined to have created a hazardous condition, the resident will be required to contract with a certified hazardous waste removal contractor and pay all fees associated with the disposal of the material. Residents in violation will no longer be able participate in the container drop-off program.

In consideration of Orange Village providing a container for the undersigned's use, I agree as follows:

1. I have read the attached Container Usage Guidelines and that I understand and agree to comply with all its provisions.
2. I understand that the delivery and removal of the waste container requires the use of a 20 ton truck by the Village, which may result in damage to the driveway, lawn or landscaping on the property. I acknowledge the risk of any damage to the property and to release and hold harmless the Village, its employees or officials from any claim for damages, which may result from the Village delivering and/or removing the waste container from the property.
3. I shall be responsible and pay for any damage to the container, except for ordinary wear and tear, while the container is on the property and agree to release, hold harmless and indemnify the Village, its employees and officials for any claims for damage or injury which may occur as the result of the use of the container on the Property.
4. I will be present at the time of delivery of the waste container to receive the container.
