# **A. ORDINANCE 2017-30**

An Ordinance amending and repealing certain sections of the Codified Ordinances of Orange Village regulating hotels and motels located in the Village. 3<sup>rd</sup> Reading

## 9. New Business and Consideration of:

#### **A. ORDINANCE 2017-32**

An Ordinance amending Section 1331.04 of the Codified Ordinances of Orange Village regarding Premises Identification. 1st Reading

Mr. Byron stated that this will require all homes to have an address on them. This is for the safety of residents and is helpful for the fire, police, building and service departments.

#### **B. ORDINANCE 2017-33**

An Ordinance amending Section 147.04 of the Codified Ordinances of Orange Village by the enactment of a new subsection (C) which would authorize additional Deferred Compensation Plans to be offered to Village Employees. 1st Reading

Mr. Byron stated the administration currently has 2 options for financial advisors through OPERS and ING. This allows the administration to allow for as many plans as necessary that would benefit the Village employees.

## **C. ORDINANCE 2017-34**

An Ordinance amending Section 147.15 (B) of the Codified Ordinances of Orange Village to conform to the Police Collective Bargaining Agreement for the contract period January 1, 2017 through December 31, 2019. 1st Reading

Mr. Byron stated that this is just a "clean up" of the code. This change refers to persons hired after 1998 regarding longevity provisions.

#### **D. ORDINANCE 2017-35**

An Ordinance granting certain variances to True North Energy, LLC, for its property located at 27010 Chagrin Boulevard. 1st Reading

Mr. Kline said that the gas station will have a much better plan. They will replicate the station on the west side of I-271/Chagrin Boulevard and Park East Dr. President Duber referred Ordinance 2017-35 to the Planning & Zoning Commission.

# E. RESOLUTION 2017-5

A Resolution accepting the amounts and rates as determined by the Budget Commission and authorizing the necessary tax levies and certifying them to the County Fiscal Officer.
