- 9. Old Business of Pending Legislation and Motions

A. ORDINANCE 2017-37

An Ordinance granting a variance to Chagrin Highlands, LTD. for grading in a limited portion of the riparian setback. 2^{nd} Reading

B. ORDINANCE 2017-40

C. ORDINANCE 2017-41

An Ordinance approving the editing and inclusion of certain ordinances as parts of the various component codes of the Codified Ordinances of Orange Village, Ohio, and declaring an emergency. 1st Reading

Mr. Byron stated this is an annual ordinance that brings the code into harmony with state code updates.

D. ORDINANCE 2017-42

An Ordinance approving and confirming the appointment of Stephen Hovancsek & Associates, Inc., as Orange Village Engineer and repealing certain ordinances. 1st Reading

Mayor Mulcahy stated there is no rate change for the Engineer.

E. ORDINANCE 2017-43

An Ordinance amending Section 776.02 of the Codified Ordinances of Orange Village to correspond with Chapter 718 of the Ohio Revised Code, repealing certain ordinances, and declaring an emergency. 1st Reading

Mr. Byron explained that the state changed the code and RITA is recommending this change.

11. Audience comments relating to matters which advance the good of the Village

Former Orange Village resident of 14 years, Walter Krongold was present. Mr. Krongold currently lives in Solon. He frequently visits the Orange Village Park to walk the trails and would like Council to consider plowing them in the winter so that people can enjoy them year round. Council President thanked Mr. Krongold and will discuss with the Service Director and Administration.

12. Committee Reports and Comments by Council Members:

Mrs. Perry: The Finance Committee met and reviewed the budget. There were very minimal changes, the committee recommends the Management Operating Budget for 2018 to Council for approval next week.

Mr. Barron: The Board of Education had a search firm in town last week. Brady Middle School is going out for bids; budgeted for \$333K; actual is \$265K.

Mr. Braverman: Thank you to the voters.

Mr. Hirsch: Thank you for the appointment.

Mr. Kline: The Planning & Zoning Commission met and approved the Hotel complex to replace Super 8. Noticed a police cruiser on I-271 ticketing today and remains concerned about officers' safety.

Ms. Kluter: Referred to newspaper articles in the Plain Dealer and the Chagrin Valley Times about gun control. Polled some residents and friends and people would like to have a town hall meeting regarding this subject.
