### A. ORDINANCE 2017-5

An Ordinance authorizing the Vacation and Dedication for a portion of Orange Place and parcels "D" and blocks "A", "B" and "C" to create a new alignment for Orange Place. 1st Reading

Mr. Singerman explained this is for dedication purposes only. The Village Engineer approved. Council President Duber referred Ordinance 2017-5 to the Planning & Zoning Commission.

- 11. Committee Reports and Comments by Council Members

Mrs. Perry: There is a new member of the Finance Committee, Brent Silver. The Finance Committee will ask for Council's confirmation next week. The Finance Committee reviewed the option of purchasing vs. leasing the Police Department cars. Purchasing them would be a cost savings of around \$13,000 which would be interest charges. A motion will be on the agenda next week regarding the purchase of the cars. The Garden Committee only lost one member from last year.

Mr. Barron: The Board of Education met and began to analyze problems they had especially in sub groups being African American, Individual Educational Plans, and lower income families; 1/3 of students in third grade are below grade level.

Mr. Braverman: no report.

Mr. Hirsch: The Village received the new site plan for the playground. The Village will surplus the old equipment.

Mr. Kline: The Planning & Zoning Commission will meet on February 21, 2017 to discuss the Master Plan.

Ms. Kluter: Would like to pursue the derelict homes in the Village and would like legislation. President Duber asked Law Director Byron to survey other communities to see what they do regarding those properties. Ms. Kluter asked Mayor Mulcahy about the Recreational Trails? Mayor Mulcahy stated that many residents were visited and are pleased with the plans. There will be a Public Meeting on Thursday, February 16, 2017 at 7pm for residents on Lander and Harvard roads.

- 12. Comments by the Mayor: The Police Department cars were budgeted for lease however purchasing would save about \$13,000 in interest fees. A motion will come in front of Council next week then an amendment to the budget will be made before the end of the year. Also, a resolution regarding storm water management will be on the agenda for next week along with an ordinance for tap in fees for the Hidden Valley water line.

- 14. A Motion to adjourn into Executive Session for the purpose of discussing pending or prospective litigation and hiring and compensation of a public employee with the Village's Legal Counsel and Police Chief Kostura was made by Mr. Hirsch seconded by Mr. Kline.
