D. DISCUSSION OF DRAFT ORDINANCE 2017-__

An Ordinance providing for the submission to the electors of Orange Village of an amendment to Section 4 of Article VII of the Orange Village Charter which would require Council to submit a recall election to the electorate not less than sixty (60) nor more than seventy-five (75) days after receiving a valid petition for recall, and declaring an emergency.

Mr. Byron explained that this was generated due to the Board of Elections calling him. This is something for Council to decide if they would like to adopt in July or wait until next election. The decision to wait until next election was made.
