ORDINANCE NO. 2017-11

AN ORDINANCE AMENDING SECTION 111.03 OF THE CODIFIED ORDINANCES OF ORANGE VILLAGE REGARDING THE COMPENSATION OF MEMBERS OF COUNCIL AND THE COUNCIL PRESIDENT.

WHEREAS, Article III, Section 8 of the Village Charter gives this Council the power to fix all compensation paid by the Village; and

WHEREAS, Article III, Section 8 of the Village Charter requires changes to the compensation of any member of Council to be introduced in an odd numbered year, passed before August 1st of that year, and made effective no earlier than January 1st of the following year; and

WHEREAS, this Council desires to increase the compensation of Council Members and the President of Council, effective January 1, 2018~~6~~, by amending Section 111.03 of the Codified Ordinances of Orange Village; and

WHEREAS, Council has held a public hearing regarding this Ordinance, pursuant to law.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF ORANGE VILLAGE, CUYAHOGA COUNTY, STATE OF OHIO:

SECTION 1. That Section 111.03, Compensation, of the Codified Ordinances is hereby amended to read and provide, in its entirety, as follows:

“111.03 COMPENSATION.

(a) Effective January 1, 2018~~6~~, the President of Council shall be paid compensation at the rate of ~~one thousand one hundred eight hundred~~ dollars (\$1,100~~800~~.00) per month, payable monthly.

(b) Effective January 1, 2018~~6~~, the members of Council, other than the President of Council, shall be paid compensation at the rate of ~~one thousand seven hundred~~ dollars (\$1,000~~700~~.00) per month, payable monthly.”


SECTION 2. That existing Section 111.03 of the Codified Ordinances of Orange Village, and any ordinance or any part of any ordinance in conflict with this Ordinance, are repealed.

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to

the public, in compliance with all legal requirements including Chapter 105 of the Codified Ordinances of Orange Village.

SECTION 4. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
