ORDINANCE NO. 2017-27

## AN ORDINANCE

AMENDING SECTION 139.05 OF THE CODIFIED ORDINANCES OF ORANGE VILLAGE REGARDING THE COMPENSATION FOR SERVICE DEPARTMENT MEMBERS WHO RESPOND TO EMERGENCY FIRE AND/OR RESCUE CALLS.

WHEREAS, Section 139.05 of the Codified Ordinances of Orange Village establishes the compensation for members of the Service Department who respond to emergency fire and/or rescue calls received by the Village; and

WHEREAS, Council desires to amend the Section 139.05 to modify the compensation paid to Service Department members who respond to emergency calls based on a member's certification.

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF ORANGE VILLAGE, CUYAHOGA COUNTY, STATE OF OHIO:

<u>SECTION 1</u>. That Section 139.05, Compensation for Emergency Fire and/or Rescue Calls, of the Codified Ordinances is hereby amended to read and provide, in its entirety, as follows:

## "139.05 COMPENSATION FOR EMERGENCY FIRE AND/OR RESCUE CALLS.

Each full-time member of the Service Department who responds to emergency fire and/or rescue calls during normal work schedules, maintains certifications as hereinafter provided, and is a member in good standing with the Fire Department as set forth in rules and regulations promulgated by the Fire Chief, shall receive additional compensation in accordance with the following schedule, based upon the member's highest level of certification:

CERTIFICATION	ADDITIONAL COMPENSATION
Paramedic	\$ 3,200/year
Advanced EMT	2,800/year
Firefighter and EMT	2,400/year
Firefighter or EMT	1,400/year''

<u>SECTION 2</u>. That existing Section 139.05 of the Codified Ordinances of Orange Village, and any ordinance or any part of any ordinance in conflict with this Ordinance, are repealed.

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Chapter 105 of the Codified Ordinances of Orange Village.

<u>SECTION 4</u>. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
