- 8. Old Business of Pending Legislation and Motions

A. ORDINANCE 2018-15

An Ordinance determining to proceed with the acquisition, construction, installation, equipping, and improvement of a Recreational Trail within Orange Village, together with all necessary and proper appurtenances. 2nd Reading

Mayor Mulcahy briefly explained the note process.

9. New Business and Consideration of

A. ORDINANCE 2018-16

An Ordinance amending Section 145.01 of the Codified Ordinances of Orange Village regarding the Composition of the Fire Department. 1st Reading

Chief Wilson explained this Ordinance adds an additional officer and is due to the expansion of Pinecrest. This was budgeted.

B. ORDINANCE 2018-17

An Ordinance amending Section 145.08 of the Codified Ordinances of Orange Village regarding the Fire Department's additional Holiday Compensation. 1st Reading

Mayor Mulcahy explained this Ordinance changes when the 'time and a half' begins.

C. ORDINANCE 2018-18

An Ordinance amending Section 1325.03, Approval of Plans, of the Codified Ordinances of Orange Village modifying preconditions which must be satisfied before a building permit is issued by the Building Commissioner. 1st Reading

Mayor Mulcahy stated this Ordinance clarifies a complex section of the code regarding how plans are assigned for review. Mr. Byron noted this was at the request of the Building Commissioner.

D. ORDINANCE 2018-19

An Ordinance amending subsection (m) of Section 1175.11, Land Planning/Site Development Principles and Criteria, of the Codified Ordinances of Orange Village, to prohibit the collection of rubbish from and deliveries to the rear of any building located in the Pinecrest Planned Development District during certain night-time hours. 1st Reading

Mayor Mulcahy explained that PD-1 had this restriction in the original code, this Ordinance incorporates all of Pinecrest now. President Duber referred Ordinance 2018-19 to the Planning & Zoning Commission.

E. RESOLUTION 2018-2

A Resolution of Orange Village, Cuyahoga County, calling on the Ohio General Assembly to enact a ban on the sale of assault weapons and ammunition magazines in excess of ten rounds.

A Motion was made for passage of Resolution 2018-2 by Mrs. Perry seconded by Ms. Kluter.

Mr. Kline: The Planning and Zoning Commission met 4-3-18. The signage and wayfinding for Pinecrest was approved. Last week's Regional Economic Development Group meeting with Ohio's 12th District was well received at Orange Village.

Ms. Kluter: Traffic from Pinecrest is still a concern at rush hour. Mayor Mulcahy explained that traffic studies were conducted. At the highest peak hour on the busiest day of the year, the predicted delay at Harvard and Brainard will be 7/10 of one second. If this is not correct, they are under obligation to conduct another traffic study 18 months after significant occupancy date and make any corrections necessary.

Ms. Kluter expressed concern about dog feces in bags left throughout the park. Mayor Mulcahy said there was an article in the last enews regarding dog clean up. Ms. Kluter will be attending the Ohio Ethics Commission seminar in April.
