Mr. Bilsky: The kids at Brady Middle School are able to participate in voting on renovation samples such as carpet, etc. Questioned solicitors in Orangewood over the weekend – Mayor Mulcahy had them as well and identified them as religious solicitors. Peddlers' need to register with the Police Department but religious solicitors do not.

Ms. Kluter: Also moved by the momentum of the kids' movement at school walkout. Pushing for some sort of Resolution for gun control. Mayor Mulcahy announced that the City of South Euclid passed a resolution calling on the Ohio General Assembly to enact a ban on the sale of assault weapons and ammunition magazines in excess of ten rounds. Mayor Mulcahy will forward a copy to the Law Director and Clerk of Council for Council's consideration in April.
