ORDINANCE NO. 2018-21

AN ORDINANCE

CREATING THE POSITION OF TREASURER/TAX ADMINISTRATOR OF ORANGE VILLAGE, ESTABLISHING THE COMPENSATION RANGE FOR THAT POSITION, AND DECLARING AN EMERGENCY.

WHEREAS, the Mayor has recommended that the administration of the Village could be streamlined by the combination of the current part-time position of Treasurer with the current full-time position of Tax Administrator; and

WHEREAS, pursuant to Article V, Section 1 of the Orange Village Charter this Council has the authority to vest the duties of the Treasurer and Tax Administrator in a single officer; and

WHEREAS, this Council finds and determines that it is in the best interest of the Village to consolidate the duties of Treasurer and Tax Administrator in a single employee; and

WHEREAS, pursuant to Article III, Section 8 of the Charter of Orange Village this Council must establish the compensation of officers and employees of the Village.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF ORANGE VILLAGE, CUYAHOGA COUNTY, STATE OF OHIO:

SECTION 1. That the position of Treasurer/Tax Administrator shall be created, effective May 1, 2018. The Mayor shall determine the compensation for the position of Treasurer/Tax Administrator at a rate of compensation which falls within the salary range established in Section 2 hereof.

SECTION 2. That the salary range for the Treasurer/Tax Administrator shall be as follows:

Position	Salary Range Minimum	<u>Salary Range Maximum</u>
Treasurer/Tax Administrator	r \$85,000	\$125,000

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings held in compliance with all legal requirements including Chapter 105 of the Codified Ordinances of Orange Village.

<u>SECTION 4.</u> That this Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabi-{01513365-1}

tants of Orange Village and, further, for the reason that the Village seeks to provide compensation for the position of Treasurer/Tax Administrator, which is a cost effective combination of a full-time employment position and a part-time employment position; wherefore, this ordinance shall be in full force and effect from and after its adoption and approval by the Mayor, provided it receives the affirmative vote of five (5) members of Council, otherwise it shall take effect and be in force from and after the earliest period allowed by law.
