ORDINANCE NO. 2018-19 (AS AMENDED)

## AN ORDINANCE

AMENDING SUBSECTION (m) OF SECTION 1175.11, LAND PLANNING/SITE DEVELOPMENT PRINCIPLES AND CRITERIA, OF THE CODIFIED ORDINANCES OF ORANGE VILLAGE, TO PROHIBIT THE COLLECTION OF RUBBISH FROM AND DELIVERIES TO THE REAR OF ANY BUILDING LOCATED IN THE PINECREST PLANNED DEVELOPMENT DISTRICT DURING CERTAIN NIGHT-TIME HOURS.

WHEREAS, the Village presently prohibits the collection of rubbish from, and deliveries made to or from, the rear of any building located in Pinecrest Planned Development District ("PPDD") Zoning Sub-District PD-1 between the hours of 8:00 pm and 8:00 am; and

WHEREAS, this Council desires to amend and expand this prohibition to include PPDD Zoning Subdistricts PD-1 through PD-4; and

WHEREAS, this matter has been referred to the Planning and Zoning Commission for a report and recommendation.

## NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF ORANGE VILLAGE, CUYAHOGA COUNTY, STATE OF OHIO:

<u>SECTION 1.</u> That existing Subsection 1175.11(m), Land Planning/Site Development Principles and Criteria, is hereby amended to read and provide as follows:

## "1175.11 LAND PLANNING/SITE DEVELOPMENT PRINCIPLES AND CRITERIA.

\*\*\*

(m) From 8:00 pm to 8:00 am, no rubbish shall be collected from, or deliveries made to or from, the rear of any building located in Sub-District PD-1Sub Districts PD-1, PD-2, PD-3 or PD-4 the front of which faces north, south or west. From 8:00 pm to 8:00 am, no trucks shall make any deliveries to the rear of any building located in Sub-District PD-1Sub Districts PD-1, PD-2, PD-3 or PD-4 the front of which faces north, south or west.

\*\*\*"

<u>SECTION 2.</u> That existing Section 1175.11(m) of the Codified Ordinances of Orange Village, and any ordinance or any part of any ordinance in conflict with this ordinance, are repealed to the extent of the conflict.

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Chapter 105 of the Codified Ordinances of Orange Village.

SECTION 4. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.
