Ms. Kluter: I have been to Pinecrest a few times and it is very nice but wondered about the parking and Mayor Mulcahy stated there is plenty of space in the parking garage. Mayor Mulcahy has also authorized the purchase of a police and fire cart to easily patrol the parking garage. The elevators at the movie theater is not very visible. The signage on the elevator by the office buildings looks more like a restroom. The red house is supposed to come down very soon.
