14. New Business and Consideration of:

A. ORDINANCE 2018-36

An Ordinance enacting a new Chapter 181 of the Orange Village Codified Ordinances to create the Orange Village Tax Incentive Review Council. 1st Reading

This Ordinance establishes, as required by statute, the tax incentive review council and the chair is the County Fiscal Officer. Mayor will appoints two Orange Village residents to the TIRC, for alternating two year terms, and council will exercise confirmation authority over such appointments. An appointment will then be made annually at the Council's organizational meeting each January.

B. ORDINANCE 2018-37

An Ordinance Declaring the Improvement of certain Real Property to be a public purpose pursuant to Revised Code Section 5709.40(b); declaring such improvement to be exempt from real property taxation; designating public infrastructure improvements to be made that will directly benefit such property; requiring annual service payments in lieu of taxes; designating a Municipal Public Improvement Tax Increment Equivalent Fund for the deposit of such service payments; and authorizing compensation payments to the Orange City School District; and declaring an emergency. 1st Reading

This ordinance is for a non-school TIF for part of the Chagrin Highland south project. The non-school portion of the property tax will be put into a special fund to be used by Orange Village for infrastructure improvements in the Village related to the project. Matt Stuczynski will be at the first meeting in November to discuss this issue.
