D. ORDINANCE 2018-37

An Ordinance Declaring the Improvement of certain Real Property to be a public purpose pursuant to Revised Code Section 5709.40(b); declaring such improvement to be exempt from real property taxation; designating public infrastructure improvements to be made that will directly benefit such property; requiring annual service payments in lieu of taxes; designating a Municipal Public Improvement Tax Increment Equivalent Fund for the deposit of such service payments; and authorizing compensation payments to the Orange City School District; and declaring an emergency. 3rd Reading

Council introduced Dr. Campbell, Superintendent of Orange Schools. Dr. Campbell thanked the Mayor for her letter and for keeping them informed about the TIF. Mr. Puster stated he will be working to secure a member from the schools. Mr. Puster, Treasurer Orange Schools, also stated that the school district refinanced their debt and saved the taxpayers \$1.4 million in interest costs.

An Ordinance amending Section 931(B) of the Codified Ordinances of Orange Village requiring persons and/or entities to make a cleaning and repair deposit for use of the Village Municipal Facilities and declaring an emergency. 2nd Reading

I. ORDINANCE 2018-42

An Ordinance authorizing the Mayor to enter into an Agreement with the Village of Moreland Hills for the joint purchase and operation of a sewer camera and locator and declaring an emergency. 2nd Reading

This is the Ordinance Mr. Duber requested. Mr. Duber explained it is a simple, straightforward ordinance concerning the regulation of plastic bags. He does not think it will be an adverse effect on businesses. Mr. Duber spoke with Sunny Simon concerning this and she is enthusiastic about it. Newspaper bags are not part of it. Great first step.

Mayor Mulcahy stated she appreciated the intent but there are a great deal of questions concerning this ordinance with enforcement being a big issue. A working committee was formed and will consist of Mayor Mulcahy, Mr. Byron, Bob Zugan, Bob McLaughlin,, Mr. Duber, Mr. Barron and Mr. Kline. They will work through the questions.
