ORDINANCE NO. 2018-36

AN ORDINANCE ENACTING A NEW CHAPTER 181 OF THE ORANGE VILLAGE CODIFIED ORDINANCES TO CREATE THE ORANGE VILLAGE TAX INCENTIVE REVIEW COUNCIL.

WHEREAS, this Council has authorized tax increment financing within the Village, pursuant to Section 5709.40, et seq., of the Ohio Revised Code; and

WHEREAS, pursuant to Section 5709.85(A)(2) of the Ohio Revised Code, a Tax Incentive Review Council ("TIRC") must be established, and the Village must appoint two (2) members of the TIRC; and

WHEREAS, this Council desires to enact an ordinance formally creating the Orange Village TIRC, establishing the composition of the TIRC and the method of appointment of the Village's representatives on the TIRC, and stating Council's intent to act on recommendations of the TIRC in accordance with state law.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF ORANGE VILLAGE, CUYAHOGA COUNTY, STATE OF OHIO:

SECTION 1. That a new Chapter 181, "Tax Incentive Review Council", of the Codified Ordinances of Orange Village, be and the same hereby is enacted which shall read and provide, in its entirety, as follows:

"CHAPTER 181 TAX INCENTIVE REVIEW COUNCIL

181.01 CREATION OF COUNCIL.

The Orange Village Tax Incentive Review Council ("TIRC") is created by operation of Section 5709.85 of the Ohio Revised Code

181.02 COMPOSITION OF TIRC.

The TIRC shall consist of three representatives appointed by the government of Cuyahoga County, two representatives of Orange Village, the Cuyahoga County Fiscal Officer or a designee of the Cuyahoga County Fiscal Officer, and a representative of the Orange City School District in Cuyahoga County appointed by the Board of Education. The two members appointed by Orange Village, who must be residents of Orange Village shall be appointed by the Mayor, subject to Council's concurrence by the affirmative vote of four (4) members. The County

Fiscal Officer, or the designee of the County Fiscal Officer, shall serve as the Chair of the Council.

181.03 DUTIES.

The TIRC shall take such actions and perform such duties as are required under Section 5709.85 of the Ohio Revised Code.

181.04 VILLAGE COUNCIL ACTION.


Orange Village Council shall, within sixty (60) days of receipt of a written recommendation from the TIRC, hold a meeting and vote to accept, reject or modify all or any portion of the recommendation.”

SECTION 2. That any and all ordinances or parts thereof in conflict herewith be, and the same hereby are, repealed to the extent of the conflict.

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Chapter 105 of the Codified Ordinances of Orange Village.

SECTION 4. That this Ordinance shall take effect and be in force from and after the earliest period allowed by law.


