# **IMPORTANT - TEST CALL** January 6, 2021 at 4:00 p.m.



Orange Village has been using the CodeRed notification system for several years as a means of dispersing emergency information quickly to our residents. We will continue to provide this wonderful service for our residents but there will be a change taking place on January 1, 2021. When we contracted with CodeRed several years ago, we paid for the usage of a nationwide phone number database from CodeRed. You may have been receiving our phone calls from this list. We will discontinue the use of the nationwide database contract on December 31, 2020. If you have registered through our website or by calling 440-498-4400 you will continue to receive our messages. If you are unsure if you signed up through the website, you can do so at any time. If you are already in the system, your information will not be duplicated.

## Orange Village will be making an EMERGENCY test call on Tuesday, January 6, 2021 at 4:00 p.m.

If you **do not** receive the phone call on January 6th, you are no longer signed up for CodeRed notifications with Orange Village. If this is the case, please register immediately via our website at www.orangevillage.com or by calling 440-498-4400.

You have the capability of registering several phone numbers and email addresses. The information can be sent via phone, email and text (phone and email are utilized the most). EMERGENCY notifications may include utility outages, water main breaks or police issues. GENERAL notifications include planned road closures, paper shredding notifications or other community events.

### PLACEMENT OF SNOW AND DEBRIS

With winter coming, we can rest assured we will have plenty of snow to remove from our driveways and parking lots. Please remember to obey our ordinance concerning placement of snow and debris. Also, make sure any snow removal contractors you hire are registered with Village Hall. For the safety of all, do not place snow on the recreational trails.

725.02 PLACING SNOW OR DEBRIS NEAR FIRE HYDRANTS AND/OR ROADWAYS

(a) No person shall transport, snow plow or otherwise place snow, ice or other debris within seven (7) feet of a fire hydrant to conceal or limit access to such hydrant.(b) No person shall transport, snow plow or otherwise place snow, ice or other debris upon the paved portion of any roadway.

### **PARKING BANS**

Orange Village Police Department reminds residents and visitors of the overnight parking ban, Codified Ordinance #351.03. No person shall park a vehicle on a public street between the hours of 3:00 a.m. and 6:00 a.m. or any time when snowfall exceeds two inches. Enforcement of this ban is necessary for a multiple reasons including:

- Prevention of street usage for vehicle storage
- Assist the police department with detection of and the possible deterrence of criminal activity
- Safe passage of motorists and early morning deliveries
- Efficient removal of abandoned vehicles
- Assist the service department during snow removal operations

### Parking Ban - 3:00 a.m. to 6:00 a.m.

Officers will place a warning citation on the windshield of any vehicle found on the street between 3:00 a.m. and 6:00 a.m. The warning will include the Codified Ordinance number and language. If the same vehicle is found on the street a second time, between the hours stated above, a parking citation will be placed on the windshield. The fine for this violation is \$25 if paid within 30 days and will increase to \$125 if paid after 30 days.

### Parking Ban - Snowfall exceeds two inches

This law enables the service department to clear snow from the streets allowing everyone including emergency vehicles the ability to move through the Village safely. This ban remains in effect for 24 hours or until the end of the snow event and the streets have been cleared. If there is a forecast of heavy snow, please consider removing the vehicle from the street in advance.

If you have overnight guests or are having work done, you may contact Orange Village Police Department during normal business hours at 440-498-4401 and request an exemption. Exemptions are only temporary and must be renewed by calling each day you need one.

Our hope is to clear village roads nightly with a friendly warning and compliance. We hope to do this without issuing citations.

### **SHOP WITH A COP**

The Orange Village Police Department will partner with other local police departments to participate in the annual "Shop with a Cop" holiday program. Thanks to the generosity of our residents and village employees, we have been able to participate in this program for the past 18 years.

### Orange C.A.R.E.S. Call Program

Orange Village implemented the Orange "C.A.R.E.S. call"; a phone call program to residents who may desire this service. Those who participate in the program will be contacted via telephone by a Village staff member twice a week (on a day and time of your choosing) as a means of ensuring the well-being of the resident.

You may enroll on our website or by contacting Orange Village Police Department, Monday through Friday between 8:30 a.m. and 4:00 p.m. at 440-498-4401.

The Orange C.A.R.E.S. program also provides residents with community volunteers that are willing to pick up medicines, groceries, or provide a "helping hand" on a temporary basis. Assistance will be assessed on an individual basis and is intended to be non-technical and short term. ### **ASSISTANCE WITH PLACING YOUR CANS AT THE STREET**



If you are having difficulty taking your trash and recycle containers to the street on a weekly basis and are willing to pay a nominal fee to have this accomplished, please contact Anna Girardi at 440-287-5131. Orange Village has obtained the names of vendors that provide this service, for a fee. The Village does not endorse or investigate any company that offers this service. We will provide the vendor information to the resident. If any party desires to provide this service for a fee, please contact Anna Girardi at the number above.

### **News from the Service Department**

### LEAF COLLECTION

- Collection began on October 12<sup>th</sup> and continues through November 25<sup>th</sup>
- ❖ Leaves should be placed close to the edge of the road. They should not extend onto the road. Leaves should be in a long row no farther off the road than 8 feet.
- Do not mix branches or foreign objects with the leaves. This can cause damage to the machine that picks up the leaves.
- ❖ The leaves will be turned into a rich compost (leaf humus) that can be added to gardens and soil. The compost will be delivered next May to residents that request loads. You can begin to place your leaf humus order on March 1, 2021.
- Do not place leaves in ditches.

### IF THE RECREATIONAL TRAIL IS IN FRONT OF YOUR HOME:

- > Leaves must be placed between the road and trails. No exception.
- > Residents with a large amount of leaves should make a long narrow row of leaves instead of one large pile. The row should not block the trails.
- > Our leaf machine will reach approximately 8 feet. Leaves farther than that will need to be brought closer to the road or they will not be collected.

**Branch chipping** is complete for 2020. We will not be chipping again until 2021. If you currently have branches out, they must be removed or you will be in violation of Ordinance 939.04.


### **CFL Bulbs and Fluorescent Tubes**



Compact fluorescent lamps and other energy-efficient lighting contain a very small amount of mercury. While mercury is a useful element with many applications, it can pose a threat to human health and the environment if thrown in the trash or flushed down a sink. The Home Depot® and Lowe's Home Improvement offer free in-store recycling of consumer compact fluorescent light (CFL) bulbs in their stores.

Fluorescent tubes can be recycled at Batteries Plus Bulbs stores, for a nominal fee. Currently the fee is \$.60 for tubes less than 4 feet and \$1.20 for 4 foot to 8 foot tubes. This is a small price to pay to save the planet.

### PEDESTRIAN CROSSING - TRAIL SAFETY





Please take a moment to discuss the usage of our recreational trails with your family. Advise your children that every driveway should be considered an intersection and all who travel throughout the trails will need to focus on their own personal safety. Drivers, please back out or pull into your driveway carefully looking both ways to ensure there is not a pedestrian on the path.

### SNOW PLOW CONTRACTORS MUST REGISTER

Please advise your contractor that they must obtain a written permit from the Village and a decal which



should be prominently displayed on the registered vehicle(s). Instruct your snow plow service provider to apply with the Orange Village Building Department and pay an annual license fee in the amount of \$25.00 and \$5.00 for each additional vehicle. For your safety, please remind your contractor to keep snow and debris out of the roadway and do not block the fire hydrants.

### **Donate Your Glasses**

Orange Village has a collection box for your used glasses. Please bring your gently used glasses, including prescription glasses or sunglasses, and readers to Orange Village Hall, 4600 Lander Road. The glasses will be donated through the Eye Make A Difference program.



They are unable to accept broken or damaged eyewear or cases.

### FLOOD PROTECTION INFORMATION

In 1968, Congress created the National Flood Insurance Program (NFIP). This program provides flood insurance at a reasonable cost in exchange for the careful management of flood prone areas by local communities. The Village of Orange participates in the NFIP; you can protect your home and contents through the NFIP.

Homeowner's insurance polices do not cover damage from floods. However, because Orange Village participates in the National Flood Insurance Program, you can purchase a separate flood insurance policy. Flood insurance covers the building and its contents. Renters can insure their possessions. Everyone in the Village is eligible to purchase flood insurance. You do not have to live in the floodplain to qualify. Flood insurance covers all surface floods and can be purchased from a licensed insurance agent.

The Federal Government backs this insurance. There are two floodplains in the Village of Orange; a tributary to Tinker's Creek and Willey Creek. A detailed floodplain map is available at the Orange Branch of the Cuyahoga County Library. Fortunately, the Village has been spared from floods in recent history. This fact however should not make us complacent. Hydrologic studies indicate that under specific circumstances, the floodplain can and will someday flood. If you live in the floodplain, the odds are that someday your property will be damaged.

Do not accept statements from present owners, neighbors or sellers that a property in question has never been flooded. Investigate for yourself. The local library contains floodplain maps, instructions for interpreting these maps and flood protection publications. The Village Engineer, Service Department and Building Department can help you determine if your property is located in a Special Flood Hazard Area and provide assistance for drainage problems on or near your property. For technical assistance such as identifying the causes and ways of preventing or stopping flood damage to your property, please call the Village Engineer at 216-731-6255.

Several of the Village's efforts depend on your cooperation and assistance. Here is how you can help:

If you live next to a ditch or stream, please help keep the banks clear of debris and heavy vegetation.

- Do not dump or throw anything into ditches, streams and detention basins. Dumping in streams and ditches is a violation of local regulations; it should be reported to the Orange Service Department or Village Engineer immediately. Even yard waste can block an existing watercourse resulting in flooding.
- All development in the floodplain, not just building construction, requires a permit. Before you buy or build in the floodplain, contact the Building Department for details. Contact the Building Department or Village Engineer if you suspect illegal development in the floodplain.

There are several ways to minimize flood damage to your home. Regrading your property so that water is directed away from structures is an example of one of these methods. The Building Department or Village Engineer can help you with this. Also, installing a plug or standpipe can help eliminate minor sewer backup. Overhead plumbing is also a method for eliminating sewer backup for more severe cases of flooding. More information about these methods and other flood proofing and retrofitting measures are available at the Orange branch of the Cuyahoga County Library.

### FLOOD SAFETY AND EVACUATION TIPS

- Plan escape routes to higher ground.
- During heavy rainfall, monitor the level of water in drainage ways. Stay tuned to local radio and television for possible flood warnings.
- Evacuate the flood hazard areas in times of impending flood or when advised to do so by the Police or Fire Department.
- · Do not attempt to cross a flooding stream on foot or by car.
- If you car stalls in high water, abandon it immediately and seek higher ground.
- Keep children away from flood water, ditches, culverts and storm drains.

IF A FLOOD THREATENS YOUR HOME, PROTECT YOUR PROPERTY BY DOING THE FOLLOWING:

- Open basement windows to let water in to equalize pressure.
- Move important or expensive items to a higher floor.
- Put small appliances in plastic bags and store in a high place.
- Remember to lock your house if you must evacuate.
- Turn off water, gas and electric at shut off points.

### **DO NOT KNOCK REGISTRY EXPIRES 12/31/2020**

The Do Not Knock Registry has allowed residents to add your property to our database in order to protect your home from unwanted solicitation. Orange Village Police Department maintains the list and provides the information (address only) to all solicitors that register to go door to door. It will be a violation of the law for the person to knock on the door or ring the doorbell of any property that is registered on the "Do Not Knock Registry" or that has a sign which reads "Canvassers and Peddlers Prohibited.

The registry expires every two years and all previous information will automatically be removed from the list on 12/31/2020. If you are currently registered and provided your email address, we will send an email explaining this situation with a link to reregister. A new sticker will be mailed when you reregister.
