2020 HIGHLIGHTS

- ☆ Reviewed and updated all policies in the police department. Received the highest accreditation from the Ohio Collaborative Police Standards
- ☆ Orange Village residents disposed of 95.6 pounds of old solid medications.
- Received grants totaling over \$81,000.
 These helped fund training for fire department personnel as well as items ranging from N100 respirators, filters, our annual recycling calendar, BearSaver recycle/trash containers, maintenance material for road repairs, and HVAC equipment for the police department
- Renovated the police department and portions of the municipal center with new flooring, paint, bath vanity and aerial photo in the Wooddell room
- Completed the planting of 750 trees received from the Great Lakes Restoration Initiative grant
- ☼ Numerous park improvements were made including the installation of electricity to the playground area in anticipation of the new restroom facility, replacement of backstops on the ball fields and repaved 90% of the park trails
- ☆ The building department completed 900 code inspections, issued 500 permits (19 for new homes) and registered 425 contractors
- ☆ Collected 2064.25 yards of leaves in 2019 which resulted in the delivery of 1026 yards of leaf compost

- Designed and maintained a COVID-19 resource website for residents and businesses
- ☆ Provided weekly electronic newsletters (Enews) or CodeRed phone notifications to residents providing Orange Village residents with COVID-19 updates
- ☆ Implemented an Orange CARES call program (a staff member will contact residents that are on the list once or twice a week during a time specified to check in on them) and volunteer program during the pandemic which we plan to continue
- Recognized members of the Senior Class of 2020 from both high school and college by displaying their name and picture on our electronic sign. A specific time was provided to each student if they wanted to take pictures next to the sign
- ☆ The finance department transitioned to a new software program while providing information for our biannual audit amid a pandemic
- ☆ Received over \$283,000 in funding for items related to the Coronavirus from CARES ACT funding and county relief funding
- ☆ An Orange For the Holidays Coupon book was created which provided savings for Orange Village residents while allowing residents to support our local businesses
- ☆ Constructed 7.65 miles of recreational trails.

Child Car Seat Installation

Snow Parking Ban

Orange Village would like to remind residents that there is a Village-wide parking ban during snowstorms that exceed 2 inches. Code Section 351.03 states that no person shall stand or park a vehicle, except when necessary to avoid conflict with other traffic or to comply with the provisions of this Traffic Code, or while obeying the directions of a police officer or traffic control device. This allows for the Village crews to plow the streets safely and to maintain access for all emergency vehicles.

Storm vs. Sanitary Sewers

Spring is coming and so is the rain. Before the spring storms arrive, please take a moment and review the sewer information from our service department. The information, with pictures, can be found on our website (www.orangevillage.com/service-department). The goal is to assist residents and homeowners by informing them of the differences between storm and sanitary sewer systems as well as septic systems and how they work. You will also find information concerning where responsibility lies for different types of issues and who to contact when/if a problem occurs.

What a year! For me, 2020 was a year of much anxiety and uncertainty. Navigating through was very tricky at times. As far as Orange Village is concerned, every single department was touched, to some degree, by the insidious spread of COVID-19 through our community. Yet, the delivery of essential services to our residents were never impacted or delayed in any way. We are very proud of that accomplishment in 2020. I want to extend my gratitude to all the employees for their extra concern and dedication to the residents of Orange Village. Special gratitude to Administrative Assistant Anna Girardi and Fire Chief Bob Wilson who

stayed abreast of all the voluminous, sometimes conflicting and constantly changing COVID-19 information on behalf of Orange Village. Anna maintained our COVID-19 Resource page and prepared timely and relevant bi-weekly electronic newsletters (e-news) during this ongoing crisis. Chief Wilson managed the guidance for our staff and orchestrated our internal preparation and supply management. Of course, the pandemic put additional duties and responsibilities on each of our staff members who gave us their all. We pray that our residents were spared the worst of this pandemic. I am confident, and hopeful, we will see improvement and some semblance of "normalcy" as early as the third guarter of 2021.

In any event, 2021 will be a productive year for our community. Our goals for this year include:

- The construction of a permanent restroom facility in our park near the playground.
- To review our facilities for future modifications. Our "new" village hall is 26 years old already!! Some of the needs and sizes of our departments may require updates to continue to provide the highest level of service, now and into the future.
- While it is hard to predict how/when the economy will recover and what that means to development in the Village, we are aware of some projects that are beginning to surface for our consideration. You will be kept up to date as any plans progress. We will continue towards achieving our goal of preserving at least 50 acres of the environmentally significant land near the intersection of Harvard and Brainard Roads.
- Finalizing this round of construction of recreational trails throughout the village for our \$5,000,000 roll out of trails, courtesy of Pinecrest. I know there are other streets wanting to be included in this amenity and we will be watching for funding opportunities to explore expanding the trails even further.
- We are evaluating other methods of communicating with you and ways to expand transparency into our government. It would be very helpful if residents would submit their ideas and questions to me so I can better respond to items that residents would like to know. 


Sources of Municipal Income Taxes




2019 TOTAL GENERAL FUND REVENUES

Income tax collections are the Village's primary source of revenue for all essential services. Every department within the Village relies on income tax collections for a major portion of their funding. Orange Village collects a 2.0% income tax on earned income within the Village which is applied to gross salaries, personal services, compensation and net income of forprofit organizations that conduct business in Orange Village. Orange Village residents are required to pay income taxes on income they earn outside the Village, but are given a 60% credit (up to a limit of 1.5%) for income taxes paid to the municipality(s) in which they work. These rates have remained the same since 1983.




2019 TOTAL GENERAL FUND EXPENDITURES

Distribution of Your Real Estate Taxes

A fundamental difference between Orange Village and the Orange School District is the main funding source used by each entity for operating purposes. Orange Village relies primarily on income tax revenues. Orange Schools rely mostly on property taxes. However, property taxes are still a vital component of Orange Village's funding sources.

Property tax in Orange Village is based on the county-assessed value of all parcels of land within each taxing district. The assessment of value is administered by the Cuyahoga County Fiscal Officer. The County Fiscal Officer determines an assessed value, which is 35% of the appraised market value for each parcel.

The value is updated every three years based on the average price that surrounding or similar properties sold for within the previous three-year period. Every six years, the County Auditor revisits all properties to reappraise the value of each piece of land based on any building additions or major improvements. The last reappraisal of property values occurred in 2018.

RECREATIONAL FIRES - INFORMATION FROM YOUR FIRE DEPARTMENT

The members of the Orange Village Fire Department hope that winter has been a safe and healthy season for our residents. As we transition to spring, we would like to take a moment to remind residents of our ordinances related to recreational fires and our prohibition related to open burning.

While most residents comply with our regulations, we have also experienced some who fail to comply. Failure to adhere to our regulations raises issues related to safety, nuisance and neighbor disputes. So before you decide to construct your fire pit, burn a pile of branches or host a bonfire we would like to offer up our general guidelines for recreational fires within the Village.

WHAT IS ALLOWED?

Under our current regulations a resident may have a recreational fire on their property. A "recreational fire" is defined as a fire that is contained in a 3' diameter by 2' high firepit or other commercially rated fire units such as a chimenea or outdoor fireplace. These fires must not be left unattended and must use wood that is properly seasoned. Burning unseasoned or "green" firewood causes significant smoke and can be a nuisance to neighbors. Any recreational fire using unseasoned wood may be shut down by our Police Department or representatives from the Fire Department. Recreational fires may NOT use garbage, building materials or other artificial materials.

WHAT IS NOT ALLOWED?

The Village does not permit any open burning. Open burning is any fire not classified as a recreational fire. An example would be the collection of yard waste on bare ground. You may have heard that if a resident piles up some branches they can open burn as long as food is present (hot dogs etc..) this IS NOT TRUE. Any burning outside of the parameters listed above for recreational fires is not permitted and may be shut down.

DON'T BE A VICTIM

The Orange Village Police Department would like to remind residents to make every effort to park motor vehicles inside during the night, if you are able. If you must park a vehicle in the driveway, it is important to lock the doors and remove the key or key fob from the vehicle. Store any items that you are unable bring into your home at night inside the trunk, so they are out of sight. The Northeast Ohio region is seeing increased motor vehicle thefts and theft of items from motor vehicles, particularly during the night. It's always a good practice to follow these tips to reduce the likelihood of your vehicle becoming a target.



The Orange Village Police Department provides vehicle lockout assistance, by request. Remember, no time is a bad time to call the Orange Village Police Department! Be a good neighbor and report anything suspicious.

SCAM ALERTS

There are always people that try to take advantage of others. Scams and scammers come in all shapes and sizes and unfortunately they're rarely obvious. Learn about recent scams and how to recognize the warning signs. Remember, never give your bank information or your social security information to anyone that calls you. If you are not sure of a company, ask for their phone number and contact the Cuyahoga County Department of Consumer Affairs at 216-443-7035. Read the FTC's most recent alerts including a scam aimed at training programs, rental assistance, COVID-19 vaccinations and tracing, job offers and much more on their website at www.consumer.ftc.gov. Cuyahoga County Consumer Affairs offers information on how to deal with robocalls.
