A. ORDINANCE 2021-9

AN ORDINANCE REPEALING THE REQUIREMENT THAT CERTAIN PERSONS WHO ENTER UPON AND UTILIZE CERTAIN VILLAGE PARK FACILITIES WEAR A FACIAL COVERING (MASK) AND DECLARING AN EMERGENCY. 1st Reading

Administration requests suspension of the rules Mayor Mulcahy removed the request for the suspension of the rules due to the fact that Mr. Silver, who requested the Ordinance, was not in attendance this evening. Council President Duber stated that some children are not old enough to wear a mask or be vaccinated and are at risk at the park. Discussion ensued concerning the requirement for wearing facial coverings (masks) at certain park facilities.
