The project has been approved as noted by the Village Architect and is pending the Village Engineer's review. The applicant has responded to the Village Engineer comments and is under review. The home will have 4 bedrooms and 5 bathrooms. It has a 1st floor owner's suite and a great room. It has a 3 car garage and will have a dog run behind the garage. The covered porch is 4.365' into the rear setback line. The Commission has the authority to approve the adjustment of the internal rear set back line. Ms. Kathy Moran would like the front step widened to the width of the sidelights. Mr. Randy Kertesz stated the homeowner may change some of the exterior selections. If they change the submitted selections, Mr. Kertesz will need to come back to a future meeting to advise of the changes. The exterior selections as submitted are as follows:
