#### **PZ/ABR Discussion:**

The project is approved by the Village Architect and approved as noted by the Village Engineer. This is the Pulte Homes Bourges model and is 3,617 square feet with 4 bedrooms and 3.5 bathrooms. The home will have a sunroom, fireplace and a vaulted ceiling in the family room. Per the Village Engineer, Pulte Homes may wish to add an additional step in the garage and lower the garage floor elevation. The proposed grade of 8.9% is steep for a driveway grade. Pulte Homes will need to resubmit the site plan. Mr. Jud Kline stated a step would need to be added in the garage and the front porch. Mr. Kline also said there appears to be enough room in the rear of the home for a future deck. The exterior selections are as follows:

# PZ/ABR Discussion:

The project has been approved by the Village Architect and approved as noted by the Village Engineer. This is the Pulte Homes Bourges model and is 3,424 square feet with 4 bedrooms and 3.5 bathrooms. The home will have a vaulted ceiling in the gathering room and a rear covered porch. It will also have a free standing tub in the master bathroom. Per the Village Engineer's comments, he stated the rear yard basin in southwest corner was left low because of the existing grade and to control drainage. The basin should be raised to the proposed grade of the subdivision plans (adjusted 6" higher). This will provide adequate drainage and allow a slightly gentler slope in the rear yard, without the adjustment and proposed patio area added at a later date will leave even steeper slopes to the basins. Mr. Gabe Kirksey will consult with the Village Engineer and Neff Engineering for final approval. The exterior selections are as follows:
