PZ/ABR Discussion:

The project was approved by both the Village Architect and Village Engineer. This is the Pulte Homes Bourges model and will have 3,424 square feet with 4 bedrooms and 3.5 bathrooms. It will have a fireplace with a vaulted ceiling in the living room, covered porch and a free standing tub in the owner's bathroom. The porch will be elevated due to the daylight basement. Mr. Brian Hitt, Ms. April Skurka and Mr. Jud Kline all agreed a revised site plan should be submitted showing the grading plan. The exterior selections are as follows:

535 SILVER LAKE DRIVE - S/L 87 - NEW HOUSE

PZ/ABR Discussion:

The project was approved by the Village Architect and approved as noted by the Village Engineer. This is the Pulte Homes Bourges model and will have 5,645 square feet with 4 bedrooms and 4.5 bathrooms. There will be a finished basement that will include a bedroom and bathroom. It will also have a sunroom, vaulted living room ceiling and a free standing sub in the owner's bathroom. The commission stated there is a rear door going to nowhere. There is not enough room for a deck or a patio. There should be stairs and a landing off of the door, otherwise, what is the purpose of the door. Mr. Gabe Kirksey stated they could do that or remove the door and add a window; whatever the homeowner decides. Mr. Jud Kline stated the one pair of shutters are unnecessary. Ms. Kathy Moran pointed out the eyebrow on the right elevation is not centered. The exterior selections are as follows:

50 WALL STREET - WHOLE FOODS - VARIANCE REQUEST - FOUR (4) CHARGING STATIONS

Present via Zoom:

Gregory Brenner, WB Engineers

PZ/ABR Discussion:

The applicant is seeking a variance from the required setback of 60 feet from Orange Place right of way to construct four (4) charging stations not less than 4 feet from the right of way to Orange Place. The variance is roughly 56 feet. The Village Engineer gave contingent approval as noted. Mr. Gregory Brenner stated they worked with the concern of the fire department and the Board provided great insight on placement. Captain Larry Genova said he is happy with the placement of the charging stations. EV-Go, Whole Foods and WB Engineers reached an agreement of the placement and will provide all the Village Engineer's requirements. EV-Go charging stations can be paid for by an app on phones or by credit card. It will take approximately 20-40 minutes to charge depending on the size of the battery and the car. Ms. Kathy Moran said the charging area could benefit from landscaping. Mr. Jud Kline stated he likes the location of the charging stations and is concerned with putting landscaping around the area due to safety concerns. Lithium car battery fires are very difficult to put out and having landscaping around the area would be an encumbrance. Having the area clear is the best way for safety services to get to the area. He also said Whole Foods and EV-Go are making a statement with the charging stations and feels the visibility is good. Mayor Mulcahy stated the landscaping can be discussed administratively between Mr. Gregory Brenner, Ms. Kathy Moran and Mr. Bob McLaughlin.

A Joint Motion was made to recommend the variance of 56 feet for 50 Wall Street – Whole Foods- Four (4) charging stations to Council and to approve the construction of the four (4) charging stations with a follow up discussion on the landscaping administratively between Mr. Gregory Brenner, Ms. Kathy Moran and Mr. Bob McLaughlin was made by Mayor Mulcahy; Seconded by Mr. Brian Hitt.
