within, the ten mill tax limitation; therefore, be it

RESOLVED, By the Council of the Village of Orange,

by the Budget Commission in its certification, be and the same are hereby accepted; and be it further

RESOLVED, That there be and is hereby levied on the tax duplicate of said Village the rate
