ORDINANCE NO. 2022-20

**AN ORDINANCE
 CREATING THE POSITION OF ASSISTANT BUILDING/HOUSING
 INSPECTOR, FULL-TIME, OF ORANGE VILLAGE, ESTABLISHING
 THE COMPENSATION RANGE FOR THAT POSITION, AND
 DECLARING AN EMERGENCY.**

WHEREAS, the Mayor has recommended that, for departmental continuity and efficiency, the Council create the position of Assistant Building/Housing Inspector, Full-Time, within the Building Department; and

WHEREAS, pursuant to Article V, Section 1 of the Orange Village Charter this Council has the authority, by ordinance, to create new offices within departments of the Village’s administration; and

WHEREAS, this Council finds and determines that it is in the best interest of the Village to create the position recommended by the Mayor; and

WHEREAS, pursuant to Article III, Section 8 of the Charter of Orange Village this Council must establish the compensation of officers and employees of the Village.

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF ORANGE VILLAGE, CUYAHOGA COUNTY, STATE OF OHIO:

SECTION 1. That the position of Assistant Building/Housing Inspector, Full-Time, shall be created, effective January 1, 2023. The Mayor shall determine the compensation for the position of Assistant Building/Housing Inspector, Full-Time, at a rate of compensation which falls within the salary range established in Section 2 hereof.

SECTION 2. That the salary range for the Assistant Building/Housing Inspector shall be as follows:

<u>Position</u>	<u>Salary Range Minimum</u>	<u>Salary Range Maximum</u>
Assistant Building/ Housing Inspector, Full-Time	\$45,000	\$95,000

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council

and of any of its committees that resulted in such formal action were in meetings held in compliance with all legal requirements including Chapter 105 of the Codified Ordinances of Orange Village.

SECTION 4. That this Ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of Orange Village and, further, for the reason that the Village seeks to create and provide compensation for the position of the Assistant Building/Housing Inspector, Full-Time, effective January 1, 2023; wherefore, this ordinance shall be in full force and effect from and after its adoption and approval by the Mayor, provided it receives the affirmative vote of five (5) members of Council, otherwise it shall take effect and be in force from and after the earliest period allowed by law.




