

ORDINANCE NO. 2023-7

AN ORDINANCE

AMENDING SECTION 145.01, COMPOSITION, AND REPEALING SECTION 145.07, COMPENSATION FOR ATTENDANCE AT CLASSROOM SESSIONS FOR FIRE/SAFETY SCHOOLING, OF CHAPTER 145, FIRE DEPARTMENT, OF THE CODIFIED ORDINANCES OF ORANGE VILLAGE, AND DECLARING AN EMERGENCY.

WHEREAS, the Orange Village administration has advised this Council of the need to change the composition of the Village's Fire Department, relating to the number of department officials; and

WHEREAS, the Orange Village administration has advised this Council of the desire to terminate the per meeting compensation for attending training as such compensation is and should be paid under the existing wage scale for firefighters.

NOW THEREFORE, BE IT ORDAINED BY THE COUNCIL OF ORANGE VILLAGE, STATE OF OHIO:

<u>SECTION 1.</u> That existing Section 145.01, Composition, of the Codified Ordinances of Orange Village is hereby amended to provide as follows:

"145.01 COMPOSITION.

- (a) The Fire Department shall be composed of a Fire Chief, an Assistant Fire Chief, up to six seven additional officers, consisting of one (or more) captain(s) and lieutenant(s), and not more than fifty other members. All officers and members of the Fire Department shall be appointed by the Mayor, subject to the confirmation of Council.
- (b) The Fire Chief may be a part-time or full-time position, upon a determination by the Mayor."

<u>SECTION 2.</u> That existing Sections 145.01, Composition, and Section 145.07 Compensation for Attendance at Classroom Sessions for Fire/Safety Schooling, of the Codified Ordinances of Orange Village along with any ordinance or any part of any ordinance that conflicts with this ordinance, is repealed to the extent of the conflict.

SECTION 3. That the actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were held in compliance with all legal requirements including Chapter 105 of the Codified Ordinances of Orange Village.

SECTION 4. That this ordinance constitutes an emergency measure in that the same provides for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of

Orange Village and, further, that this ordinance needs to be effective immediately in order to facilitate the proper composition and compensation for the Village's Fire Department; wherefore, this Ordinance shall be in full force and effect from and after its adoption and approval by the Mayor, provided it receives the affirmative vote of five (5) members of Council, otherwise it shall take effect and be in force from and after the earliest period allowed by law.
