#### **PZ/ABR Discussion:**

The project has been approved by the Village Architect. The site plan has not been approved by the Village Engineer as minor storm water issues need to be resolved and the site plan revised.

Ms. Moran stated her Columbus office started working for Pulte and she does work for the Columbus office. Ms. Moran will abstain and not perform landscaping reviews on Pulte homes.

This dwelling is located on lot 46 and will be a 3,414 sq. ft. single-family home with 4 bedrooms and 3.5 bathrooms.

Mr. Lazar questioned the garage window on the left elevation and stated it should be centered. Mr. Filipkowski stated they will center the window. Mr. Filipkowski also noted there was a clerical error in the front elevation with the front steps and stated the steps will be at least as wide as the front door.

The discussion shifted to the rear grade, proposed rear deck, stepped foundation and building projections. Ms. Skurka asked what finish will be applied to the stepped foundation. Mr. Filipkowski responded the foundation will have gray colored brick applied.
