

**A RESOLUTION
HONORING COUNCILMAN BRANDON DUBER ON THE
OCCASION OF HIS RETIREMENT FROM THE COUNCIL OF
ORANGE VILLAGE.**

WHEREAS, Councilman Brandon Duber has been a dedicated and valued member of the Orange Village Council for over a decade, having been elected to serve on the Village Council in 2011; and

WHEREAS, Councilman Brandon Duber was elected by his peers on Council to serve as the President of the Orange Village Council for nine (9) years; and

WHEREAS, Brandon Duber announced at a Village Council meeting on January 11 his intention to step down from his role as President of Council and further announced that this year would mark his last year serving on the council, culminating a remarkable 12-year tenure in office; and

WHEREAS, Brandon Duber has faithfully represented the interests of Orange Village residents during his three consecutive four-year terms, contributing to the growth and development of our community; and

WHEREAS, Brandon Duber is an active member of the Park Synagogue in Pepper Pike and Cleveland Heights, demonstrating his commitment to both faith and community; and

WHEREAS, Brandon Duber's leadership and dedication have played an integral role in the success and progress of Orange Village, earning him the respect and admiration of his colleagues, constituents, and the entire community; and

WHEREAS, Brandon Duber came onto the council at a time of rancor and incivility, with the goal of ending that atmosphere, and Mayor Kathy U. Mulcahy stated:

Brandon came onto council at a time of rancor and incivility. His goal was to end that. I am pleased he accomplished his goal and led council for nine years as its president. He brought calm back to council; and

WHEREAS, Mayor-elect Jud Kline offered the following praise for Councilman Brandon Duber:
