MINUTES ORANGE VILLAGE COUNCIL SPECIAL COUNCIL MEETING DECEMBER 6, 2023 7:45 PM

PUBLIC HEARING 7:45 P.M.

The purpose of the hearing is to consider Ordinance No. 2023-16. This Ordinance, if enacted and confirmed by a majority vote of the Orange Village electors at an election to be held on March 19, 2024, would enact zoning regulations for a new "Orange Place South Planned Development District" and rezone property into that district.

Council President Kurland opened the public hearing concerning Ordinance No. 2023-16 at 7:45 p.m.

Gary Biales, Vitalia – presented this information to the Planning and Zoning Commission and Council. Mr. Biales explained the project (active adult/independent living). Solon is independent and memory care. There will be many factors for the planned project. They are working around the wetlands. Tonight council is voting on allowing the rezoning to be placed on the ballot for voters in March 2024.

Charles Maimbourg, 28499 Jackson Rd. - asked what the property is currently zoned. Mayor Mulcahy stated it is currently residential

Tom Lowenkamp, 3850 Beechmont Oval – inquired if the zoning passes and the project does not go through can anyone come and build something on the property. The answer was yes.

Jeremy Caldwell, 28899 Harvard Road – expressed concern on the impact on the safety forces and EMS services. Will there be an independent study to find out what impact this project will have on the community? Mayor Mulcahy stated that every department will weigh in on the project.

He would like the moratorium for 5 years. Mrs. Kurland stated that 5 years is a long time. Mayor Mulcahy stated 5 years seems like a ban instead of a moratorium. Discussion on the time frame of the moratorium ensued.

Mr. Zugan requested that council please look into rules and regulations in the park including marijuana.

A Motion to direct the Law Director to draft legislation for a one-year moratorium for a recreational marijuana facility in Orange Village was made by Mrs. Kurland seconded by Mr. Silver.

13. Old Business of Pending Legislation and Motions

Mr. Duber has an issue with the commercial aspect of this project. He likes the residential but the one issue is the hotels and the types of restaurants. He will be voting no on this project. He foresees a problem when you change the zoning you cannot undo it. He does not feel there will be enough safety forces to fulfill the project and it does not have a clear plan.

Mrs. Perry stated that Mr. Duber has a good point and we worked very hard to make sure restaurants/hotels are set up to a higher standard.

Discussion ensured concerning the vote for the rezoning. Mr. Kline stated that the zoning includes a commercial aspect of this project due to economics.

Mr. Biales stated we have worked on this for months and it is 30 pages of text. He is not 100% sure they will be building a hotel but it is in there in case it is needed. Mr. Kline stated that items can be identified in the Development Agreement but may not be in the zoning.

Mr. Duber is fine with this if they can remove the hotel aspect. This can be amended to remove the hotel aspect. He feels we are not forward thinking on this Ordinance and what the project will be.

Mr. Byron stated this is the change of the district. They are not voting on the text of the document.

Mr. Singer, 30149 Harvard Rd, wanted to know why the project has retail. Is it too hasty?

Tom Lowenkamp, 3850 Beechmont Oval - asked how will the voters know what they are proposing so the voters know what they are voting for including hotels and restaurants?

Jeremy Caldwell, 2899 Harvard Rd – he agrees with Mr. Duber but is there an ability for voters to make the deal work.

Mr. Biales stated that they prefer not to remove the hotels they are willing to do so

A Motion to amend the Ordinance to remove the hotel aspect from the Ordinance was made by Mrs. Kurland seconded by Mr. Bilsky.
