The proposed dwelling will be 6,500 sq. ft. with 6 bedrooms and 9 bathrooms.

Mr. Kline submitted comments and sketches regarding this project relating to the lack of a roof plan, front entry asymmetry, sections of siding at the garage and the intersection of the porch roof and master bedroom gable on the rear elevation. Ms. Skurka went over Mr. Kline's comments with the applicant. Per the applicant, a roof plan was submitted with the engineer's stamped plan to the Building Department, but was not included in the PZ/ARB submission drawings. The front entry is offset because the homeowner would like to have furniture on the front porch. Mr. Lewis stated he has no objections to the front entryway being offset and this design is the homeowner's preference. Mr. Kline's comments addressed the vertical siding on either side of the garage and suggested it be horizontal siding. Mr. Huskins stated when looking at this area from the garage side, the siding should be vertical. Ms. Skurka stated the drawings were misleading. The discussion shifted to Mr. Kline's comment regarding the intersection of the porch roof and master bedroom gable on the rear elevation. Mr. Huskins sent a new elevation drawing via email to Ms. Vincent that was reviewed by the members of the Board. Ms. Skurka stated she was fine with the design.
