# From the Office of Mayor

Dear Neighbors,

The first sixty days of my term have just flown by. I have been very busy in acclimating to my new role in the Village. Most importantly, I have begun to build bonds and connections with our department leaders and personnel.

From day one, I have embarked on a journey to contribute and to build upon the success of my predecessor. I am using my campaign theme of ACCESS (accountability, community development, culture and arts, engagement, sustainability, and service) to advance programs and opportunities for the community.

The activities and actions I have undertaken so far include:

- Hired a police officer, Building Department Administrator, and several firefighters/paramedics
- Initiated and developed a Community Engagement Inquiry. The inquiry will be utilized to identify areas where residents feel we should invest time and resources. We have received over 115 responses.
- Requested proposals from an external facilitator to develop a community-wide survey to establish an agenda and priorities from the Engagement Inquiry.
- Met with the City of Beachwood to re-establish the boundary along Orange Place; a discussion that has been ongoing for over 20 years.
- Met with the developers to create an agreement for the Living Well Collection development, located on Harvard Road east of Cooper's Hawk. This project will be contingent on rezoning approval (identified as Issue 14 on the March 19th ballot).
- Purchased solar eclipse glasses for Orange Village residents in anticipation of the Solar Eclipse on April 8. Residents may receive up to 3 pairs (per household) to observe this phenomenon safely. Please stop by Village Hall and pick up yours.
- Began planning for the 2024 Party in the Park, which will include an environmentally friendly drone light show in lieu of fireworks.
- Initiated meetings with the Orange Art Center on a "call for artists" to produce artworks celebrating century homes in Orange Village as we approach our Centennial in 2027.
- Began discussions with the Service Department for the creation of a Veteran's memorial garden to be located outside of Village Hall.
- Met with the Western Reserve Land Conservancy to define the creation of a future park area should Issue 14 pass, and to discuss the potential of our parks evolving into an "Orange Emerald Necklace".
- Developed a concept and applied for a grant to expand and renovate the current amphitheater to host community events.

There is much more to come with an eye to the future. I encourage residents to participate and work with me and the administration so we can make Orange Village better, together.

# FINANCES OF ORANGE VILLAGE

Dear Orange Village Resident:

It is a pleasure to provide the following financial report on the Village's current fund balances and year end analysis. We are committed to transparency of our municipal finances. This will continue to be a priority of the current administration to communicate openly and regularly with Village residents about our financial status.

The Auditor of State's Office will begin our financial audit for the years 2022/2023 over the next few months. We anticipate receiving an unqualified or "clean" audit as we have in the past.

In 2023, we received grant funds for the village-wide camera project, which saw cameras installed in 30+ locations throughout the Village. We also purchased a new fire squad and dump truck. American Rescue Plan Act funds received in 2021 and 2022 were used to offset safety service wages, which helped add to the general fund year end balance. The Kathy Urdang Mulcahy Pavilion construction has been completed and is a great addition to our park area. The pavilion dedication will be held this summer.

The new RH Mansion in Orange Village is planned to open this spring and will be a welcomed addition to the community. The Orange Place South Planned Development District consisting of senior housing, commercial and parkland will be on the March ballot.

I want to thank Village Council and all of our department leaders for their commitment to fiscal responsibility and conservative budgeting. This has allowed us to remain in sound fiscal condition.

### **Sources of Municipal Income Taxes Total Received in 2023 = \$7,832,580**






# **2023 TOTAL GENERAL FUND REVENUES**

Income tax collections are the Village's primary source of revenue for all essential services. Every department within the Village relies on income tax collections for a major portion of their funding. Orange Village collects a 2.0% income tax on earned income within the Village which is applied to gross salaries, personal services, compensation and net income of for-profit organizations that conduct business in Orange Village. Orange Village residents are required to pay income taxes on income they earn outside the Village, but are given a 60% credit (up to a limit of 1.5%) for income taxes paid to the municipality(s) in which they work. These rates have not changed since 1983.




# **2023 TOTAL GENERAL FUND EXPENDITURES**

# Distribution of Your Real Estate Taxes

A fundamental difference between Orange Village and the Orange School District is the main funding source used by each entity for operating purposes. Orange Village relies primarily on income tax revenues. Orange Schools rely mostly on property tax revenues. However, property taxes are still a vital component of Orange Village's funding sources.

Property tax in Orange Village is based on the county-assessed value of all parcels of land within each taxing district. The assessment of value is administered by the Cuyahoga County Fiscal Office. The County Fiscal Officer determines an assessed value, which is 35% of the appraised market value for each parcel.

The value is updated every three years based on the average price that surrounding or similar properties sold for within the previous three-year period. Every six years, the County Auditor revisits all properties to reappraise the value of each piece of land based on any building additions or major improvements. The last reappraisal of property values occurred in 2021, which impacted the 2023 values.

### **Tips to Avoid Scams**

The best way to avoid a scam is to recognize some of the techniques scammers commonly use. You know it's a scam if:

- 1. You're told you or someone you love is in trouble. Scammers know if they impersonate police or government officials, we may trust them. Some scammers may impersonate a relative, for example, a grandchild, and ask for bail money after a car accident.
- 2. You're asked to pay in a way that's hard to trace. All unexpected requests for payments should be viewed as scams, but these payment methods are scammer favorites: Bitcoin, gift cards, money wires and mailed cash. Legitimate government agencies and utilities do not accept these forms of payments. Scammers are also beginning to lure people to pay on mobile payment apps.
- 3. You're told to lie or keep secrets. It's always a scam if someone tells you to lie to your bank or a store clerk about why you're withdrawing money, buying gift cards or sending a money wire, or keep information secret from your family and friends.
- 4. You're told you have a problem or have won a prize. Here are some examples: You're told there's a large "charge pending" against your account; you're told you've won a lottery; you get an unexpected text or call telling you there's a refund or reward pending on your account; an impostor calls to say your utilities will be shut off unless you make an immediate payment.

#### How to protect yourself:

- 1. Ignore unexpected calls and texts
  - Don't call or text back unknown numbers.
  - Don't answer calls from numbers you don't know. Block spam texts.
  - Never click on texted links you aren't expecting.
  - Ignore any call or text that threatens you with arrest, lawsuit or fines.

#### 2. Stay calm and refuse to be rushed

 Hang up if someone demands immediate payment, threatens you with arrest or tells you to keep secrets.

#### 3. Never provide private information

- Be wary of "friends" seeking money or offering investments through social media sites.
- Never share Social Security numbers, account numbers and passwords with people who contact you unexpectedly.
- 4. Verify information independently before you act
  - Never use numbers that unknown callers provide you to verify information.
  - If you're worried about an account, Do not use texted links - call the customer service number on your bill.
  - If you're worried a relative is in trouble, contact other family members to get the truth.

You can always call the police department if you get a worrying call or text.
