

**A RESOLUTION  
AUTHORIZING AND DIRECTING MAYOR JUDSON A.  
KLINE OF ORANGE VILLAGE TO COMPLETE ALL  
ACTIONS NECESSARY TO SUBMIT AN APPLICATION  
FOR THE 2025 CUYAHOGA COUNTY COMMUNITY  
PLANNING SERVICES PROGRAM, AND DECLARING AN  
EMERGENCY.**

WHEREAS, the County of Cuyahoga, through the Cuyahoga County Planning Commission, offers a competitive grant through the Cuyahoga County Community Planning Services Program (CCPS) that makes awards to continue the practice of providing professional planning and technical services to complete various planning, zoning, and related technical projects at a reduced cost for awardees.; and

WHEREAS, the Cuyahoga County Community Planning Services Program will help the Village create a way-finding system to create linkage and wayfinding system to connect Orange Village parks with the Metroparks South Chagrin Reservation in Solon and Moreland Hills.

**NOW THEREFORE, BE IT RESOLVED BY THE COUNCIL OF ORANGE VILLAGE, COUNTY OF CUYAHOGA, STATE OF OHIO:**

SECTION 1. That this Council hereby supports the efforts to secure funding from the 2025 Cuyahoga County Planning Services Program.

SECTION 2. That this Council hereby authorizes and directs Mayor Judson A. Kline to prepare and submit application to the Cuyahoga County Development Office, seeking the grant funds for the purpose of supporting Orange Village's desire to connect green space within the Village with those of adjacent communities and the regional Metroparks system. The application is marked as "Exhibit A", attached hereto and incorporated herein by reference.

SECTION 3. That Mayor Judson A. Kline is hereby authorized and directed on behalf of Orange Village to execute all instruments and to take all steps necessary in connection with the preparation and submission of the application(s) and enter into any agreement(s) as may be necessary and appropriate for obtaining this financial assistance.

SECTION 4. That the actions of this Council relating to the adoption of this Resolution were adopted in an open meeting of this Council and that all deliberations of this Council and of any committees that resulted in those formal actions were in meetings open to the public in compliance with all legal requirements including Chapter 105 of the Code of Ordinances of Orange Village.

SECTION 5. That this Resolution is declared to be an emergency measure necessary for the immediate preservation of the public health, safety and welfare of the inhabitants of Orange Village, and further, for the reason that the CDSG Grant Agreement deadline is imminent;

wherefore this Resolution shall be in full force and effect immediately upon its adoption and approval by the Mayor.




